

**FACT SHEET**  
**ISPRA HEALTH CARD APPEAL**

**WHO CAN JOIN THE APPEAL:**

Employees and Pensioners of the European Union of Ispra, both of Italian and other citizenship.

**TYPE OF APPEAL:**

Collective actions for homogeneous categories will be brought before the competent Ordinary Court. The action will be brought against the Ministry of Health and the Region of Lombardy, each within its competence

**OBJECTIVE OF THE APPEAL:**

The purpose of the main action is to establish the right to obtain a free health card for access to all services of the national health system.

**COSTS OF PARTICIPATION IN THE APPEAL**

The cost for participation in the appeal is € **150.00**, to be paid directly to Avv. Antonio De Angelis. No further sum will be requested for the entire trial.

**TIME AND PROCEDURE FOR LODGING AN APPEAL**

All necessary documentation (see next point) for participation in the appeal must be **sent** to Avv. Antonio De Angelis at the following e-mail address: **ricorsotesserasanitariaispra@gmail.com** **no later than WEDNESDAY 1 FEBRUARY**

**2023 (the date of sending of the e-mail will be taken as the date of sending).** In any case, you are advised not to wait until the last days to send the documentation. Do not send the documentation by PEC. Do not send paper documentation.

The average time to decide a case of this type is about 8/10 months.

**DOCUMENTATION TO BE SENT:**

- 1) copy of the signed power of attorney (also completed in the part concerning the indication of the identity document) - the power of attorney is the document on page 3 of this form
- 2) copy of identity document
- 3) copy of codice fiscale (health card)
- 4) copy of the bank statement for the transfer
- 5) copy of the signed declaration in lieu (doc. on page 4 of this form)
- 6) copy of the completed and signed privacy form (doc. p. 5 of this form)
- 7) copy of the signed order form and quotation (doc. p. 6 of this sheet)

In the subject line of the e-mail, only the first name and surname of the applicant should be stated.
